# IMPORTANT APPLICATION INFORMATION

## APPLICATION PERIOD

The SCBScN program is a competitive entry program. Applications to the 4-year SCBScN program for the Fall 2022 intake will be available from 8:00 a.m., October 1, 2021 until the application deadline of 4:30 p.m., February 15, 2022 (Saskatchewan time). All supporting documents (i.e., transcripts) must be submitted to Saskatchewan Polytechnic by March 15, 2022. NOTE: For international applicants with student visas, the application period closes at 4:30 p.m., December 31, 2021, and all supporting documents must be submitted by January 31, 2022.

## NORTH BATTLEFORD APPLICANTS

Accepted applicants will attend the first 3 years of the SCBScN program in Saskatoon and will complete the 4th year of the program in North Battleford. First Priority is given to applicants who are residents of the RM of North Battleford. See [rmofnorthbattleford.com/maps.html](http://rmofnorthbattleford.com/maps.html) for the areas belonging to this region.

## HIGH SCHOOL ADMISSION REQUIREMENTS

Applicants who have completed or are in the process of completing Grade 12 must present the following courses for final admission to the program with a minimum **70% in each course**. GED is not accepted in lieu of Grade 12:

- English Language Arts A30 (or French substitution)
- English Language Arts B30 (or French substitution)
- One of Foundations of Math 30 or Pre-calculus 30 or Calculus 30
- Biology 30
- Chemistry 30

Current high school students will be admitted on the basis of early conditional admission requirements ([www.sasknursingdegree.ca/scbscn/](http://www.sasknursingdegree.ca/scbscn/) apply-now) and will require the above five courses with a minimum of 70% in each course by August 1 to meet final admission requirements. Applicants from other Canadian provinces and territories or from other countries will need to present equivalent courses. Meeting the minimum requirements does not guarantee admission to the program. High school graduates with less than 15 credit hours of post-secondary coursework completed will be assessed using the five courses listed above.

## POST-SECONDARY ADMISSION REQUIREMENTS

Applicants who have completed a minimum of 15 credit hours of approved post-secondary education by the application deadline (Feb 15) will be assessed based on the following criteria:

- Post-secondary applicants must have successfully completed either the high school admission subjects (see above) or the post-secondary equivalent. Post-secondary applicants who are currently upgrading a high school admission subject past March 15 must still send one high school transcript by March 15, notify Saskatchewan Polytechnic of their currently registered high school courses, and submit another high school transcript showing final marks by August 1, **and**
- Have a minimum AGPA of 65% on the most recent 30 credit hours.

(NOTE: meeting the minimum requirements does not guarantee admission to the program.)

Applicants who have completed a minimum of 9 credit hours of Nursing-specific courses at a recognized Canadian post-secondary institution must apply for Upper Year Admission. Applicants who have completed a previous undergraduate degree should consider applying to the SCBScN After-Degree Program. A completed Upper Year or SCBScN After-Degree Application must be submitted to the University of Regina (online or printable application forms available at [www.urconnected.uregina.ca](http://www.urconnected.uregina.ca)).

## ADDITIONAL PROGRAM REQUIREMENTS

By August 1 prior to the beginning of the first term, students admitted to the SCBScN program must:

- Obtain a criminal record check and vulnerable sector search (dated within six [6] months of the start date of the program)
- Complete Workplace Hazardous Materials Information System (WHMIS) course

- Provide a record of immunization
- Complete CPR Health Care Provider course
- Complete a Standard First Aid course

By November 1, students admitted to the SCBScN must complete a Transferring, Lifting, and Repositioning (TLR®) course, and Respiratory FIT testing.

## LANGUAGE PROFICIENCY REQUIREMENTS

## TRANSCRIPTS

**High School Graduates:** Applicants who graduated from a high school in Saskatchewan must arrange for electronic copies of their transcripts to be sent to Saskatchewan Polytechnic directly from the Saskatchewan Ministry of Education. Requests to the Saskatchewan Ministry of Education must be made online at [www.k12.gov.sk.ca/etranscript/](http://www.k12.gov.sk.ca/etranscript/). Out-of-Province high school graduates must arrange for official paper transcripts to be mailed to Saskatchewan Polytechnic by March 15\*.

**Current High School Applicants:** A school-certified transcript or official transcript of marks must be submitted to Saskatchewan Polytechnic by March 15 (mail, fax, email, or electronic submission of marks acceptable). Official final transcripts (sent electronically from the Saskatchewan Ministry of Education) will be required after graduation showing all final marks by August 1.

**\*Upgrading Applicants:** High school applicants or post-secondary applicants who have completed less than 15 credit hours of post-secondary coursework who are upgrading their high school admission subjects must submit their official final high school transcripts to Saskatchewan Polytechnic by March 15. Post-secondary applicants who have completed 15 or more credit hours of post-secondary coursework and are completing high school admission subjects must submit one high school transcript by March 15 to show all high school courses completed, and submit **another** high school transcript to Saskatchewan Polytechnic by August 1 showing all final marks. If post-secondary applicants who have completed 15 or more credit hours of post-secondary coursework are still completing high school prerequisites after March 15, they must submit their official final high school transcripts to Saskatchewan Polytechnic by August 1.

**Post-Secondary Applicants:** Applicants who have completed or are currently enrolled in any post-secondary courses at an institution other than Saskatchewan Polytechnic or the U of R must submit an official transcript directly from the institution attended to Saskatchewan Polytechnic by March 15. Applicants who are currently enrolled in a post-secondary course at an institution other than Saskatchewan Polytechnic or the U of R past March 15 must also submit another official transcript directly from the institution to Saskatchewan Polytechnic showing all final marks by August 1. If your post-secondary courses are from the U of R or Sask Polytech, you do not need to submit transcripts, but you must declare these two institutions in the Post-Secondary Education section on page 2.

- One non-refundable fee of \$100.00 must be submitted by first-time applicants to the SCBScN program (previous applicants to an undergraduate program at the U of R who have already paid an application fee do not need to submit this application fee).
